



Accordingly, it is this 2nd day of August 2000, **ORDERED** that:


1. The opposition of Floyd Brown, be, and the same hereby, is **WITHDRAWN**;

4. Copies of this Order shall be sent to the Protestant and the Applicant.



TERMS OF AGREEMENT

The following are the term of agreement between G & S Liapis, Inc. (t/a Bull Feathers Restaurant) and the undersigned. This agreement is in response to Ret. CR - renewal application, Case No 11527-00082P.

Terms of Agreement

1. G & S Liapis, Inc. shall maintain in a clean and sanitary manner the area housing the trash dumpsters located in the side alley for Bull Feathers restaurant. To accomplish this, G & S Liapis, Inc. shall (weather permitting) sweep the area each morning before 9:00 a.m. and sweep and hose down the area each ~~evening~~ ^{MORNING 8:00} prior to closing.
2. G & S Liapis, Inc. shall keep the lids on the dumpsters closed at all times.
3. G & S Liapis, Inc. shall maintain the front of Bull Feathers restaurant in a clean and sanitary manner. To accomplish this, G & S Liapis, Inc. shall (weather permitting) sweep, and hose down if necessary, the front area, including the tree box directly in front of the establishment, each evening prior to closing.

As a result of G & S Liapis, Inc. carrying out the above terms, the undersigned agrees to drop all opposition to the renewal of the above referenced application.
